Co-Vice President for Fundraising of the PTA, Emily Merle, announced the photo retake day is November 4<sup>th</sup>; the Miss Chocolate fundraiser ended and the delivery date of items in November 11<sup>th</sup>; Hip Pickles, a bullying prevention group, will hold presentations to the students on November 18<sup>th</sup>, 21<sup>st</sup> and 22<sup>nd</sup> and the next meeting is on November 28<sup>th</sup> at Cornwell Avenue. Co-President Claire Galofaro added that Reflections entries are due November 1<sup>st</sup>.

PTSA Co-President, Ellen Shanley, stated that last fundraiser topped last year's; the recent Book Fair did really well; the Middle Level Institute will have workshops and to check the website for dates; the next meeting is November 14<sup>th</sup>; the Barnes and Noble fundraiser is coming up and Reflections entries are due November 9<sup>th</sup>.
